Information Items

1. Marina Security Update – James Weaver, Director of Marine Facilities

Mr. Weaver provided background on the marina security services which began June 1, 2020 and is contracted through SAFE Security. He supplied detail on the services and reports provided by SAFE highlighting that there has been a reduction in night-time law enforcement calls since the contracted services began. He responded to questions and comments from the Board and discussed the measures in place for the Port to monitor SAFE Security. He also noted other marinas and ports that utilize full-time night security personnel.

Jason Mims, SAFE Security, responded to questions from the CEO and Board commenting that, now that they are established, they can adjust their methods to better enhance their services. He also discussed questionable night-time watercraft activity within the marinas and Kathy Garcia, Marina Operations Manager, provided history on the derelict boat situation that is a contributing factor to the watercraft activity.

Jim Rothlin, Chief Executive Officer

- Executed a lease with Circuit of the Northwest for the last available office space in the Avian building. Provided background on preparing the building's upstairs for individual office spaces.
- Working with a couple of developers for existing tenants looking to expand. Commended
 Arne Bakker, Director of Business Development for building relationships and
 connecting developers and tenants.

- Completed guest activity shelter at Port Orchard Marina that was constructed by the marina facilities crew.
- The remote Seattle Boat Show is coming up with 180 plus exhibitors. The Port will be participating with a virtual booth.
- Along with Commissioner Strakeljahn and attorney Anne Montgomery, attended the Kitsap Public Facilities District (KPFD) meeting during which the Interlocal Agreement for funding for the Circuit of the Northwest public events center project was discussed. There was full discussion with the Board regarding the differences in 5-yr and 10-yr funding payback options.
- Beginning one-on-one reviews with senior staff to discuss goals for this year and confirm we are in line with what we want to accomplish and set timelines for how we plan to achieve these goals.

Warren Hendrickson, Airport Manager

• Provided an update on proposed legislative bills related to: 1) funding for the Community Aviation Revitalization Board (CARB) loan program; 2) extending the timeline for the Commercial Aviation Coordinating Commission (CACC) for two years; and 3) reallocating .5% of the 6.5% sales tax on aviation fuel sales to the Aeronautics Account from the General Fund.

- Worked with Kitsap Transit's Sanjay Bhatt on a Gorst transportation corridor video to be presented to the legislature. Also working on Memorandum of Understanding for the Gorst Coalition. Discussed reasoning for why he would like the Board to entertain a \$20,000 investment toward the coalition.
- Reported on Kitsap Aerospace & Defense Alliance (KADA) meeting held earlier in the day during which it was proposed to move KADA under Kitsap Economic Development Alliance (KEDA). There was discussion by the Board on KADA's return on investment.

• Excited to be a part of the Port when things are so busy and positive noting that his "planning" hands are full trying to get all meetings scheduled.

Commissioner Bozeman

- Bremerton Rotary requested that he speak at their next meeting because they heard so many things were going on at the Port.
- Reported on the recent Pandemic Coalition meeting stating they are still trying to figure out the best way to distribute the Covid vaccine. The hope is to get back to a semblance of normalcy by late fall, but the plan does not show we'll get there we all need to do whatever we can to make this happen.

Summary:

On September 22, 2020, Port Commission awarded the WRG Training Facility Entry Way Improvement Project to Henderson Partners, LLC. The base bid was for \$81,367 (\$88,690.03 incl WSST) and consisted of site development and construction of a 4,800-sf entryway to the WRG site.

A final acceptance inspection was completed on January 26, 2021, by Port staff.

There was one change order for this project which included removal of debris found onsite during excavation, removal of excess soils from the site, and a substitution of a specified corrugated pipe for a ductile iron pipe required by the City of Bremerton. The cost of CO-1 was \$3,752.87 (incl WSST).

Total construction costs, including change orders and WSST is \$92,442.90.

Fiscal Impact:

Total project costs including design, engineering, permitting, and construction was \$114,228.05. Of this amount, \$110,475.18 was allocated in the 2020 capital budget for Site, Utility and Building Improvements and \$3,752.87 was allocated in the 2021 capital budget for Site, Utility and Building Improvements.

Strategic Purpose:

Goal 1: Be a significant leader in promoting the local economy and job growth both on and off Port assets. The Port is an economic engine. It is authorized to build and operate facilities as well as provide more programmatic support to the community's efforts to increase job growth.

Recommendation:

Staff recommends accepting as final the construction contract with Henderson Partners, LLC., in amount of \$92, 442.90. The Port will release retainage once all documents are received by Henderson Partners.

Summary:

On August 9, 2019, Port Commission approved the design and engineering contract for the development of a 12-acre site known as the HWY3 Frontage Development. Site development and construction were approved in the 2020 Capital Budget and was awarded to Henderson Partners, LLC. This project is nearing completion. The future tenant has requested some building improvements which will accommodate their manufacturing as well as increase personnel safety and security once the building is occupied.

Change Order 6 consist of the following changes:

- Tubing and railing to be placed around the electrical paneling to prevent vehicles and trailers from backing into the existing panel.
- Raising the roll up door by 2 feet to give additional clearance to allow clearance of product into and out of building.
- Concrete pathway to roll-up door to allow easy access to move in and out of building.

The cost of this Change Order is \$9,179.98 (Incl WSST). The costs for these improvements will be partially recovered in the lease rate with the future tenant.

Fiscal Impact:

The total cost of construction, with this change order is \$2,454,745.10 which is \$195,254.90 under the total project budget of \$2,650,000.

Goal 1: Be a significant leader in promoting the local economy and job growth both on and off Port assets

Recommendation:

Port staff recommends approval of Change Order 6 in the amount of \$9,179.98 for the installation of building upgrades for the future tenant and authorize the CEO to execute the Change Order.



Summary:

On August 9, 2019 Port Staff entered into a Consultant Agreement with BLUE Architecture, LLC, for the Bid Phase, Construction Contract Administration, and Project Close-out for the SR 3 Frontage — Wedge Development. During the Construction phase, several changes in site conditions were encountered which required additional engineering and construction administration services beyond Blue's current scope of work. These changes included replacement of a section of the Port's sewer line caused by age and deterioration, and a water line relocation requested by the City of Bremerton. This contract amendment is for \$19,000.

On August 25, 2020, the Port Commission approved Change Order #5 with Henderson Partners in the amount of \$139,566.91. Within this Change Order, \$14,000 was identified for civil engineering services payable to Blue Architect, LLC. These services should have been documented as a separate engineering amendment and not via a construction change order. The purpose of this amendment is to combine the previously authorized \$14,000 and an additional \$5,000 needed for required as-built drawings of the sewer and water line and close out of the project. Subject to PSE electrical, Port staff is looking to finalize construction in March of 2021.

Fiscal Impact:

Total increase for Amendment 1 with BLUE Architecture, LLC, is \$19,000. \$14,000 has previously been approved in Change Order 5. Total project budget for the HWY3 Frontage – Wedge Development is \$2,650,000 and with this amendment the estimated final cost is \$2,454,745.10

Strategic Purpose:

Goal 1: Be a significant leader in promoting the local economy and job growth both on and off Port assets

This memorandum summarizes the extra design services N.L. Olson & Associates (NLO) has provided for the project for three unexpected reasons:

- The Existing AC City watermain was located by the City in the wrong location resulting in a relocation of the main to be able to construct the cul-de-sac serving Lot 1, which is extra work. \$6,500
- 2. The fire line was added to the project and the location of the line into the building determined. Significant coordination with the City Fire Marshal on the required permitting, as well as coordination with the design team and owner on the placement of the fire line has resulted in extra work. \$5,500
- 3. The existing sewer main owned by the Port of Bremerton was found to be severely degraded and requires replacement. Field investigation and design recommendations for replacement have been required resulting in required extra work. Note that at the time this memorandum is prepared, formal design for the relocation has not been requested. \$2,000

Therefore, the total of NLO extra work services as of August 21st is \$14,000.00. Please call if you have questions.
