## Information Items - cont'd

2. Wetland Mitigation Opportunity – Steve Sego, Waterman Mitigation Partners

CEO Jim Rothlin introduced Mr. Sego who is interested in a piece of property in Port Orchard that the Port leases from Washington State Department of Natural Resources (DNR) because it fits into a master plan project of doing wetland/environmental improvements to several properties in the area.

Mr. Sego provided an explanation of why this property is important to his project and how it fits under his umbrella mitigation bank project and provided a definition of a mitigation bank. They currently have properties from Blackjack Creek to Port Gamble being considered to include in the mitigation bank prospectus. Should they be successful in their prospectus process and should the Port Orchard master plan for the community events center come together, they will be coming back to the Board to request the Port allows them to assume the DNR lease for shoreline restoration with mitigation credits then being available to the Port for purchase.

The was full discussion with the Board on mitigation credits and the benefits to having Waterman Mitigation Partners performing the mitigation. The intent for that property has always been to restore it and use it for mitigation and having Waterman take it over would be a huge release of responsibility for the Port.

The Board agreed to provide a letter to Waterman agreeing to let them use the DNR leased property for their first step in the mitigation bank process.

## **Staff Reports**

Jim Rothlin, Chief Executive Officer

- Signed a Personal Services Agreement with Columbia Hospitality who will help with selection of a tenant for the Multipurpose Facility; managing costs on the build-out; and appropriate market rate for the lease.
- Discussed the difference in the market between when the Port could not find a developer
  to build in the industrial park, so we had to build ourselves to currently having several
  prospective tenants either looking to build themselves or use a developer.

- In collaboration with Kitsap Public Facilities District (KPUD), Port Orchard Marina has been hardwired for internet which should help stabilize the marina office for future internet needs.
- Staff met with prospective tenants that have provided letters of intent for the South Hangar Project Phase 1 hangars.
- USS Turner Joy along the Bremerton boardwalk is scheduled to reopen.
- Along with Mr. Weaver, spent 3.5 days speaking with federal legislators regarding issues and projects that are of concern to the Pacific Northwest Waterways Association (PNWA). He described the organization. We were given opportunity to speak on our Port issues, specifically, the Port Orchard Marina breakwater replacement. We followed up with official funding requests with Congressman Kilmer and Senator Murray. The Port has recently joined the organization and plan to attend again next year.
- Congratulated Mr. Weaver and his crew for Bremerton and Port Orchard Marinas being awarded certificates from the Coast Guard Auxiliary commending them for their efforts in following proper safety measures, promoting boating safety, and assisting in boater safety education.
- Along with Mr. Weaver provided an update on the timeline for the capital budget request
  for Port Orchard Marina breakwater replacement funding. Will include Dylan Doty, Port
  lobbyist, in a future meeting to provide a more detailed update on the request. Mr. Weaver
  outlined further funding requests being submitted for the breakwater and provided an
  update on the design process.

#### **Commission Reports / New Business**

#### Commissioner Strakeljahn

- Attended over 20 Zoom meetings in the last seven days sharing the Gorst corridor and why it should be the number one transportation focus item in the State of Washington.
- Reported on the recent Central Puget Sound Economic Development District Puget Sound Broadband Access Work Session.

## Commissioner Anderson

• Reviewed the Gorst project draft and am seeing that there are already results – Kitsap Transit is putting in a park and ride which is listed as one solution to the problem.

## Commissioner Bozeman

- Following the COVID vaccine scene and noted that we need to continue a strong effort at getting people in the for their vaccinations.
