CEO Jim Rothlin introduced Don and Rena Morris. The Port is currently in lease negotiations with their company, Morris Restaurant Management LLC, for the restaurant portion of the Multi-Purpose Facility at the airport.

Mr. and Mrs. Morris stated they are continuing to meet with the Port to make sure they are in line with the Port's desires for the restaurant stating this will not just be another burger restaurant. They discussed their plans for menu selection stressing that, given the location, seafood will be a main menu item while trying to keep the price-point at midrange. They discussed their ideas to stay in-tune with the community and their plans to hold fundraisers for local non-profits during their soft grand-opening. As soon as the lease is signed, they intend to join the local chamber and get more involved in the community. They responded to questions and comments from the Board. Commissioner Anderson stated he is excited about the Morris plan of attack, their connection with the local community, and is looking forward to their next steps.
