Staff Reports

Jim Rothlin, Chief Executive Officer

- Shared photo of the Multi-Purpose Facility building being erected and provided a brief update on the building progress.
- Monument sign on the north end of the airport is currently being erected.
- The Port has a booth at the Northwest Aviation Conference and Trade Show being held this weekend. He provided a description of the show.
- Appreciates James Weaver being on top of all the grants for the breakwater. Along with the RCO grant accepted earlier at this meeting, the Port received \$900,000 in 2017 as a capital appropriation through then-Senator Jan Angel. We are continuing to work on a \$2.2M state capital appropriation ask and have contracted with a federal lobbyist for a \$9M ask focusing on federal grants including money available through the infrastructure bill that was recently passed. There was further discussion on the request processes for grants and appropriations. Commissioner Bozeman expressed his disappointment that the Port did not get funding support from the state legislature for the breakwater project.

Commission Reports / New Business

Commissioner Bozeman

- Thinking back on recent conversations around leases and lease rates, reflected on the
 Port's primary mission of job creation and improving the economy and discussed how we
 are accomplishing that. We can also build parks and marinas that enhance the quality of
 life in another way. He feels the Port is accomplishing our mission and we should be proud
 of that.
- Has been following the Belfair sewer expansion being put on hold and, in response to his question as to whether the Port holds a position on that, there was full discussion with staff and the Port Attorney on the sewer project and the Port's standpoint. Commissioner Anderson requested further discussion on this topic in the near future and stated the Port needs to take a hard look at the sewer issue and devote time and money to it.

Commissioner Anderson

- Reported on the City of Port Orchard's Economic Development and Tourism Committee meeting during which growth predications within the local area were discussed.
- Reported on the Port Orchard Bay Street Association (POBSA) meeting during which they addressed what they are going to do in the next couple of years following the pandemic.

Commissioner Strakeljahn

- Participated in the public release of an update to the Washington State Space Economy Report at the Museum of Flight. He discussed highlights of the event.
- Agrees with Commissioner Bozeman's disappointment that the Port did not get legislative support for the Port Orchard Marina breakwater project funding and is hoping to get a legislative champion for us in the future.

Summary:

On October 21, 2021, the Port Commission awarded the Port Orchard/Bremerton Marina Piling Repairs Contract to Aqua Dive Services, LLC. The successful bid was for \$154,758.20 for both marinas.

A final acceptance inspection was completed on February 24, by Port staff. The scope of the work included maintenance and repairs of the underwater structural, mechanical, mooring pilings, inter-tidal coatings, and cathodic protection systems.

This contract completed maintenance on 40 pilings in Bremerton and 20 pilings in Port Orchard, including cleaning and application of epoxy at the intertidal zones, and underwater welding of 100 lb. cathodic protection anodes to the pilings. The piling work has an expected life expectancy of 25-30 years. In addition, twelve USS Turner Joy Mooring cables were replaced. This completed work is a component of the long-term marina asset repairs, specifications, and maintenance schedule that had been prepared by Art Anderson Associates.

The Port staff have worked closely with Aqua Dive Services, LLC to ensure the scope of this contract was well positioned for an efficient and successful project.

Fiscal Impact:

Total contract amount for materials and services, including applicable tax was \$154,758.20 and is funded by the 2021 Capital Budget. The total 2021 approved capital budget amount for this project was \$190,000, resulting in a total project savings of \$35,241.80.

Strategic Purpose:

This action conforms with the Port's strategic plan in Goal 6. Develop and fund a 20-year asset replacement/ major maintenance schedule

Recommendation:

Staff recommends accepting as final the contract with Aqua Dive Services, LLC., in the amount of \$154,758.20. The Port will release retainage once all documents are received by the contractor.
