Information Items

1. Space Industry's Economic Impact on the Puget Sound Region – Jason Thibedeau, Puget Sound Regional Council

Commissioner Strakeljahn introduced Jason Thibedeau, Program Manager – Economic Development, Puget Sound Regional Council (PSRC).

Mr. Thibedeau opened the presentation with background on the Washington State Space Economy Report that was developed in 2018. He discussed detail on the following elements of the recently released update to the Report:

- Regional trends such as doubling of employment and economic activity since 2018; new startups adding diversity to the industry; and businesses being at the forefront of commercial human spaceflight.
- Elements of the space economy including suppliers; space launch service providers; space-related goods and services; and space-supported businesses.
- Washington's competitive position strengths; weaknesses; opportunities; and challenges.
- Economic opportunity projected growth of the space economy.
- State economic impact which is largely concentrated in the Puget Sound Region.
- Actions needed to support the space economy noting that Aerospace Futures Alliance (AFA) is the advocate for Washington state's aerospace industry.

Throughout the presentation, Mr. Thibedeau responded to questions and comments from the Board. Commissioner Strakeljahn offered final comments on the space industry and its growth in the last 5-6 years.

2. Port Orchard Marina Breakwater Replacement Project Status Update

James Weaver, Director of Marine Facilities, provided a brief background to date on the breakwater replacement project and introduced Jon Keiser with PND Engineers, the Port's engineering firm for this project. Using PowerPoint, Mr. Keiser gave an update on the project discussing the following:

- Project schedule
- Breakwater and approach float site plan including the north and east breakwaters and the approach float.
- General project construction cost and bid concerns with current cost increases and supply chain uncertainty.

- Permitting timelines multiple permits are required
- Project funding goals and outstanding funding requests funding will be addressed more thoroughly in an upcoming meeting.

Mr. Keiser and Mr. Weaver responded to questions and comments from the Board throughout the presentation. Next step is to start submitting permits in April.

Jim Rothlin, Chief Executive Officer

- Welcomed new seasonal staff member Hunter Dorr who has joined the team as an airport Port Attendant.
- Participated in a virtual visit to Washington DC with Pacific Northwest Waterways Association (PNWA) and met with over 30 legislators on marine transportation related projects. Had an opportunity to speak directly with Congressman Derek Kilmer regarding the Port Orchard Marina breakwater replacement project. We are currently working with Congressman Kilmer and his staff on coordinating wording for specific grant requests for that project. At an upcoming meeting, we will talk more about the funding process at the federal level with our DC consultant, Desimone Consulting Group.
- Provided brief updates on the monument signage project and the new sign that will be put up at the Multi-Purpose Facility location announcing the future restaurant.

• Discussed a recent article in Kitsap Sun regarding employees in the shipyard having issues with being accosted as they leave the shipyard. Being stewards of the tenants in the Bremerton Marina, we need to pay attention and keep our facility safe.

Commissioner Anderson

- Noted that the upcoming restaurant, Amelia's Diner, was featured on the front page spread of the Kitsap Business Journal.
- Had a conversation with Port Orchard Mayor Rob Putaansuu regarding planned downtown redevelopment. They will be having ongoing meetings related to the redevelopment so he asked Mr. Rothlin and Mr. Weaver to attend those meetings with him as the Port will be an integral part of the lengthy redevelopment and we need to make sure our tenants are being taken care of.

Commissioner Strakeljahn

- Reported that the Central Puget Sound Economic Development District (CPSEDD) Board is arranging a full-day tour for its board members of Kitsap County later this year which would include, in part, Naval Base Kitsap and the Port.
- Reminded the Board of the upcoming Kitsap Economic Development Alliance annual meeting later this month.
- The State Legislature allocated \$74.2M to the Gorst corridor which is a milestone noting the Port has been a leader on the Gorst transportation issue for the last ten years. It also makes the corridor eligible for federal funding.
