 Port Orchard Marina (POM) Breakwater Replacement Project Funding Opportunities – Desimone Consulting Group (DCG)

CEO Rothlin stated the Port has been working diligently to find funding opportunities for the POM Breakwater Replacement project and has contracted with Desimone Consulting Group (DCG) for assistance with federal funding requests. He explained the benefits of using DCG and introduced consultant Rick Desimone. James Weaver, Director of Marine Facilities, shared a graphic outlining the total estimated project cost of \$15.7 million and current funding requests which include \$9.4 million in federal requests.

Mr. Desimone detailed DCG's process for assisting the Port to secure federal resources for the breakwater project and their work in educating relevant members of our Congressional delegation on the need for federal assistance. He referenced a GAO report which highlighted the difficulty that non-freight projects have in securing federal resources. He noted the breakwater project was emphasized in that report which is a fortuitous tool to use with delegation members.

He responded to questions and comments from the Board with further discussion on the GAO report and the importance of local stakeholder support.

2. Taxiway Relocation/Apron Rehabilitation Project Update (AIP 03-53-0007-035-2021) Presented by Warren Hendrickson, Director of Airport & Industrial Operations

Mr. Hendrickson's presentation addressed:

Summary:

On December 14, 2021, the Port Commission awarded the construction contract for the 5650 Imperial Way Roof Replacement & Facility Improvements Project to Contractor's Roof Service, Inc. of Gig Harbor, WA. The Port executed the contract – Port Capital Project #04-22-40003 – on January 5, 2022. The total bid award amount, including applicable taxes, was \$198,464.35.

There were three change orders (CO) under this project due to changes in field conditions:

- 1. CO 1: Extend 18 overflow drainpipes through the exterior façade and beyond the soffit.
 - a. Cost \$6,041.49
- 2. CO 2: Repair and replacement of extensive wood rot underlying fascia/siding.
 - a. Cost \$35,922.16
- 3. CO 3: Remainder of fascia repair, additional wood rot drainage repairs, and one roof section substructure repair.
 - a. Cost \$18,883.11

Contractor's Roof Service, Inc. has completed all work associated with this project in accordance with the project specifications.

A final acceptance inspection was completed on April 8, 2022 by Port staff.

The completed project is within the Port budgeted amount.
