Information Items

 Holly Community Club Presentation – Barb Peden, President and Vickie Napora Vice-President

Ms. Peden shared a brief history of the Community Club and the 1922 Schoolhouse that was destroyed by fire in April. She described activities of the Club stating that the centennial of the school was going to be celebrated in September but now will be a farewell and kickoff of the rebuild. Ms. Napora discussed their plan as they move forward which is to rebuild the community club (school) once insurance issues are settled noting the cause of the fire is still under investigation. There was discussion with the Board on the community benefits of having an active club.

Commissioner Strakeljahn remarked that the Port has been putting money aside for the Seabeck/Holly/Crosby community and would like to look at helping this club with money in those reserves. The Board reiterated the value of these clubs to the entire community.

It was moved by STRAKELJAHN, seconded by ANDERSON to:

Contribute \$30,000 out of the Port's Seabeck reserve fund toward the Holly Community Club to assist in the cleanup and reconstruction process of the community club building.

2. EAA Chapter 406 Sonex Xenos Motor Glider Project – Joel Mapes, President and Mike Friend, Flight Advisor

CEO Rothlin introduced Joel Mapes and Mike Friend stating that the Experimental Aircraft Association (EAA) is a tenant of the Port's and is in process of building what may be the first electric aircraft to fly out of Bremerton National Airport (BNA).

Mr. Mapes provided background on the EAA Chapter 406 and their youth program.

Mr. Friend provided a presentation on EAA's eXenos electric aircraft building project detailing the following:

- History on the Bremerton Aviation Center for Education (BACE)
- The eXenos building project of which several kids ages 12-14 are assisting
- Photos of an eXenos motorglider
- Shared photos and provided detail on 2022 build activities
- Advertised the project at the Northwest Aviation Expo in Puyallup
- Near term and future electric airports at BNA noting that a 220V vault will be placed on the ramp in front of the new multi-purpose facility.

Mr. Friend responded to questions and comments from the Board and staff.

Questioned what kind of solar capacity could be built for infrastructure at the airport that
would complement the charging needs of electric aircraft. Commissioner Strakeljahn
asked to have aviation director Warren Hendrickson respond directly to Mr. Marshall at a
