#### **Summary:**

The Port is in the process of applying for a CERB Planning Grant to help fund the design and engineering of 1400 linear feet of sewer and roadway improvement that is in need of replacement. As a threshold requirement, the Port is to pass a resolution as the local government authorizing a CERB (Community Economic Revitalization Board) Application.

This resolution states the Port's position as to why this project is required. The goal of the grant is to execute the design and engineering of the, much needed, sewer replacement and roadway improvement including accessible sidewalks, along Imperial Way SW. These improvements need to be made in order to provide infrastructure improvement for existing and new tenants in the Olympic View Industrial Park. The total costs of the study will be approximately \$62,500 with the CERB portion to supplement \$50,000 and the work is anticipated to be performed by NL Olson & Associates, Inc.

#### Fiscal Impact:

Capital Budget for 2022. \$12,500 which will come from the Site Utility & Building Improvement fund

#### Strategic Purpose:

This action conforms with the Port's strategic plan in Goal 2.b. to pursue cost efficiencies throughout the Port.

#### Recommendation:

Staff recommends the approval of Resolution 2022-04 authorizing an application to the State of Washington CERB for financial assistance for design and engineering of the sewer replacement and roadway improvements.

## PORT OF BREMERTON KITSAP COUNTY, WASHINGTON RESOLUTION NO. 2022-03

**DATED:** July 26, 2022

A **RESOLUTION** of the Board of Commissioners, Port of Bremerton ("Port") authorizing an application to the State of Washington Community Economic Revitalization Board for financial grant assistance leading to preparation of the design and engineering for the replacement of 1400 linear feet of sewer main in the Olympic View Industrial Park (the "Project").

**WHEREAS**, the Project is focused on the replacement of the sewer main and roadway improvements along Imperial Way SW., and

**WHEREAS**, the design and engineering of the Project will be completed by NL Olson & Associates, Inc, and

**WHEREAS**, the grant, if received, will allow the Port to commence with the design and engineering for the Project in 2022 and commence with construction in 2023 in order to better service existing and future tenants, and

WHEREAS, the Port has limited funds for the design and engineering of the Project.

**NOW, THEREFORE, BE IT RESOLVED**, by the Port Commission of the Port of Bremerton, that the Port shall apply to the State of Washington Community Economic Revitalization Board for a \$50,000 grant to assist in the Project's design and engineering by NL Olson & Associates, Inc., and that the Port's contribution to the design and engineering contract would be \$12,500.
