### Summary:

On March 22, 2022, the Port Commission awarded the LED PAPI Light installation project to Colvico, Inc. The project is an extension of the 2020 Airfield Lighting Project. The FAA agreed to amend Airport Improvement Program (AIP) Grant Number 3-53-0007-033-2019, and authorized the Port to install an LED PAPI system on Runway 20 as an AIP-eligible project. The original flight check was scheduled to take place in September but due to weather delays, downed aircraft, and other events, the flight was rescheduled ten times. However, the flight check was completed on January 3, 2023 and the FAA deemed the PAPI system to be satisfactory.
