Information Items

1. Waste-to-Energy – Katie Walters, Kitsap County Commissioner, District 3

Commissioner Walters discussed current waste generation and disposal and the opportunity with a waste-to-energy (WTE) plant to provide safe, economic waste disposal; reduce greenhouse gas emissions; and provide renewable energy. She provided detail on Washington State's only WTE facility in Spokane and highlighted the benefits and challenges to be considered in siting a WTE facility. She addressed questions and comments from the Board and closed by stating she was presenting this as information for something to consider for our future. The Board was supportive.

2. Kitsap Transit Ferry Maintenance Facility and Transit Center – John Clausen, Executive Director

Mr. Clausen provided brief background on the two Kitsap Transit (KT) projects, Transit Center and Ferry Maintenance Facility, that have the potential of affecting Port properties explaining that the Port did not hear about this earlier in the process due to federal requirements.

Edward Coviello, Transportation and Land Use Planner, reviewed the potential Port Orchard Transit Center alternative locations and the impact to parking. There was full discussion with the Board and Port staff on the Port's parking and potential parking agreement with the City of Port Orchard. Steffani Lillie, Service & Capital Development Director, detailed the federal process. Ms. Lillie responded to questions and comments from the Board.

Mr. Clausen introduced the Ferry Maintenance Facility project stating that a local location is critical to servicing the ferries quickly. Mr. Coviello discussed the facility siting study and provided aerials that showed five possible locations with one of those locations including Port property. There was discussion on the Port's site and uplands requirements and the unique challenges of each potential site. The process could take 10 years until completion, but KT would like to purchase property as soon as possible. As with the other project, KT will need to go through the proper Federal Transit Administration process for site selection.

Summary:

On December 14, 2021, Commissioners approved the Hangar 7 Stormwater project which was to re-route the stormwater drainage system and install a new underground drainage pipe at Hangar 7 to keep the hangar from flooding. On June 13, 2023, the Commission approved Change order 4 for the Hangar 7 Stormwater project which was the result of the collapse of the trench. The contractor, Henderson Partners LLC, was required by Century West Engineering to bridge the soil in order to strengthen the base, shore up the walls, dewatering, equipment rental and use, and labor in order to prevent further erosion and collapse.

Change Order 5 was also discussed for the anticipated additional labor for soils removal, backfilling the trench, compacting the new soils, paving, and compaction testing as required by the City of Bremerton on the project.
