- Congratulated David Beckley, Port Maintenance I, on his 1st anniversary working for the Port.
- Olde Thyme Aviation is moving out of the terminal building and into their new space in the multipurpose facility. Once the move is complete, the terminal space will be renovated/updated for any potential new tenant.
- American Cruise Lines delayed their arrival by one week and will now arrive at Bremerton Marina on Friday, April 14 and will return on a nearly weekly basis throughout the season.
- Provided an update on the state capital budget request for the Port Orchard Marina breakwater replacement. The earliest the budgets will be seen is April 20 but it looks like the Senate currently has allocated \$800K and the House \$1M.
- Reported on Kitsap Economic Development Alliance's (KEDA) annual economic forecast meeting during which Richard Schwarz, SAFE Boats CEO and a guest at the Port table, announced that SAFE Boats has transitioned to a 100% employee-owned company.
- Announced Seattle Times published an article discussing the success of the Bellevue downtown park which was the brainchild of Commissioner Bozeman when he was Bellevue Mayor.

# **Summary**:

In September 2022, the Commissioners approved Robblee's Total Security to repair and upgrade Airport gates 1 & 12. Installation began in March of 2023 and both gates were completed in April. In addition to the upgraded gate hardware, a new gate software access system was also introduced allowing new access cards (fobs) to be issued to staff and tenants. This new system tracks access and records all entries, adding a new layer of security to the airport.

# **Strategic Purpose:**

This action conforms with the Port's strategic plan in Goal 6: Develop and fund a 20-year asset replacement/ major maintenance schedule.

# **Recommendation:**

Port staff recommends final acceptance of the construction contract for the replacement of Gates 1 & 12 with electrical upgrades to Robblee's Total Security.

Move to accept as final the construction contract for Replacement of Gates 1 & 12 with Electrical Upgrades to Robblee's Total Security, Inc., in the amount of \$86,852.22.
