Summary:

The Grays Harbor Historical Seaport, a 501(c)(3) not-for-profit public development authority provides local visits to Puget Sound ports with their tall ship, the Lady Washington to provide historic maritime education and outreach for local communities. The moorage at the Port Orchard Marina also brings significant tourism to the community.

The Lady Washington is a full-scale replica of the original 1776 vessel, that fought in the revolutionary war and was the first American ship to visit Honolulu, Hong Kong and Japan. The original Lady Washington also was the first American vessel in our own Grays Harbor in 1792, of which the bay is named after her captain, Robert Gray.

Constructed in Grays Harbor to historical specifications, the new Lady Washington is a U.S. Coast Guard inspected and certified passenger sailing vessel. The Lady Washington has appeared in several motion pictures including Pirates of the Caribbean: The Curse of the Black Pearl. Over the years, the Lady Washington, and the benefit she provides to the local community has been a welcome addition to the Port Orchard waterfront.

Fiscal Impact:

A maximum possible impact of \$112 per day transient moorage for a maximum of 90 days, and, if extended, a maximum of \$56 per day transient moorage for a maximum of 90 days.

Recommendation:

Recommendation is for approval of the support for temporary moorage for the Lady Washington Tall Ship.

Motion for Consideration:

Move to approve the agreement with the Lady Washington Tall Ship for provision of temporary moorage on Port Orchard Breakwater and to authorize the CEO to execute the agreement.

PORT OF BREMERTON SHORT TERM USE AGREEMENT

IT IS HEREBY understood that this Use Agreement made this 28th day of February 2023, by and between the **PORT OF BREMERTON**, a municipal corporation organized under the laws of the State of Washington, hereinafter referred to as "Port", and the Lady Washington Tall Ship, a vessel owned by the Grays Harbor Historical Seaport, a 501 (c)(3) educational non-profit public development authority based in Aberdeen, Washington, hereinafter jointly referred to as "User", for and in consideration of the mutual agreements, covenants, and promises herein contained as follows:

<u>USE</u>: The Port hereby agrees to permit the User to utilize the Port Orchard Marina Breakwater for the purpose of Lady Washington tall ship education nonprofit moorage, and for no other use. User shall be responsible for correction of any and all property damage which would occur as a result in any way to User's activity. User acknowledges that they have viewed the facilities and accept them in their current condition as appropriate for their intended use with no further modifications by the Port.

TERM: The term of this agreement shall begin from date of signature and ending on December 31, 2023.

ASSIGNMENT: This agreement is not assignable or transferable in any fashion.

<u>RENT</u>: The User agrees to a maximum of 90-days moorage of \$ 0.00 per foot plus applicable taxes per day of use, and if extended, then agrees for a maximum of additional 90-days moorage to pay the Port, a minimum of \$ 0.50 per foot plus applicable taxes per day of use plus electricity, in advance. A late fee of one percent (1%) per month, minimum \$40.00 will be assessed on all accounts not paid in advance.

RISK OF LOSS: The User assumes all risks, including but not limited to, loss of or damage to equipment or property of the User, or of participants, or any other person on the premises under the terms of this agreement, or of equipment or property used or stored on the premises under the terms of this agreement.

SECURITY: Security of User's or invitees' property shall be the sole responsibility of the User. User shall prevent users, attendees and participants from traversing or accessing any and all parts of the Port of Bremerton, Port Orchard Marina facility, except those areas open to the public and that area designated herein for User's purpose, and specified ingress and egress thereto.

INSURANCE AND INDEMNITY: The User shall secure comprehensive general liability insurance (Form CG-001) for property damage and bodily injury at the premises in an amount of not less than \$1 million per occurrence and \$2 million aggregate. In addition, User shall keep and maintain in full force and effect during the term of this agreement fire and extended coverage insurance on all fixed improvements located or situated on or in the Premises to the full insurable value thereof. Proceeds from such insurance shall be used to restore the Premises. User shall provide the Port with a certificate of insurance, naming the Port as an additional insured (CG 2010 [form B]) and the premises shall be listed as a covered site on all coverage. The User agrees to hold the Port, its officers, employees and agents harmless from any liability and/or suits for such injuries or property damage as any person might receive or believe he has received from the acts or omissions of the User, their agents, or employees, or any other person(s) using the premises under the terms of this agreement while operating at the Port of Bremerton, including the expense of litigation. No occupancy or use permitted under the terms of this agreement shall commence until such evidence of insurance is presented to and approved by the Port. User agrees to assume full responsibility for the conduct of all persons involved in the said use of the premises.

<u>CANCELLATION</u>: This agreement is subject to immediate termination with or without cause by the Port. No written notice is required.

Summary:

The existing north and east breakwaters have protected vessels moored at the Port Orchard Marina for more than 48 years and now the facilities have far outlived their original design life and needs replacement. The Port Orchard Marina Breakwater Replacement project has been in the design and permitting process for more than 2 years. The replacement construction project, as part of the permitting process, includes Sinclair Inlet habitat mitigation for potential impacts within the normal and accustomed tribal fishing rights areas of the Suquamish Tribe.

In 2005, the Port of Bremerton entered into an agreement with the Suquamish Tribe. The proposed amendment to that agreement includes provisions specific to the Port Orchard Marina Breakwater Replacement project. The agreement amendment assists Port efforts for securing State and Federal funding and helps the approval of the federal permit process.

Fiscal Impact:

Fiscal impact to the Port of Bremerton includes an agreement to allot an additional 40 linear feet of moorage along the Port Orchard Marina Breakwater for Tribal Fishing vessels and cargo offload.

Strategic Purpose:

Goal 6. Develop and fund a 20-year asset replacement/major maintenance schedule.

Recommendation:

Port staff recommends the approval of Amendment 1 to the Agreement between the Port of Bremerton and the Suquamish Tribe.

Motion for Consideration:

Move to approve Amendment 1 to the 2005 Agreement between the Port of Bremerton and the Suquamish Indian Tribe and authorize the Commission President to execute the Amendment.

AMENDMENT 1 TO THE AGREEMENT BETWEEN

SUQUAMISH INDIAN TRIBE AND PORT OF BREMERTON February 28, 2023

This Amendment is made to the Agreement Between Suquamish Indian Tribe (Tribe) and Port of Bremerton (Port) December 8, 2005 (Agreement) regarding the Port's proposed Port Orchard Marina Breakwater Replacement project. The Port and Tribe agree that the rights and obligations under the Agreement will be amended to include:

- 1. Commencing immediately upon execution of this Amendment, the Port agrees to provide the Tribe with an additional 40 lineal feet of moorage, for a total of 240 lineal feet of moorage, on the inside of the Port Orchard Marina breakwater without any fees or costs to the Tribe or Tribal fishermen.
- 2. The Tribe will transmit a letter to the Port of Bremerton in support of securing federal funding grants and Washington State funding grants for the Port Orchard Marina Breakwater Replacement project. This letter will be mailed within five (5) business days of the Tribe's execution of this Amendment.
- 3. The Tribe will transmit a letter to the U.S. Army Corps of Engineers stating that the Tribe does not oppose the issuance of the Section 10 permit for the Port Orchard Marina Breakwater Replacement project (U.S. Army Corps Permit No. NWS-2022-513). This letter will be mailed within five (5) business days of the Tribe's execution of this Amendment.
- 4. The Port agrees to meet with the Tribe no later than June 15, 2023 to discuss the Port's continued obligations regarding the educational program for Marina users and others regarding the Tribe's treaty fishing rights and use of the Port Orchard Marina. In accordance with the Agreement, the Port and Tribe will continue to meet annually in early June.
- 5. This Amendment is conditioned upon the construction and continuing existence of the Port Orchard Marina Breakwater Replacement project, as designed on the date of execution of this Amendment, located at 707 Sidney Parkway in the City of Port Orchard. If, at any time, the Port Orchard Marina Breakwater Replacement project design changes without the prior written approval of the Tribe, or the project is not pursued by the Port the provisions of this Amendment will be null and void without further action by either party.

Summary:

The roofs of OVIP #3 (Belfair Hose) and OVIP #6 (IMIA) have reached the end of their effective life span. OVIP #3 is the third oldest Port-owned building in the Industrial Park. On January 10, 2023, Port Commission gave the notice to proceed for Port staff to go out to bid for the replacement of both roofs.

On February 14, 2023, bids were received for Port Project Number 04-23-40004-C. A total of five bids were received. Signature Roof Services, LLC. of Kent, WA offered the winning bid including sales tax at \$272,999.45. The highest bid received was \$352,674.06. This included the addition of insulation for both roofs as an alternate bid.

Port staff has completed their due diligence on Signature Roof Services and finds the company in good standing. The company has shown significant expertise in commercial roofing installations with favorable reviews on the quality of work, schedule, and ability to remain within budget.

Fiscal Impact:

This is a 2023 approved capital budget project (OVIP Roof Replacements).

- Capital Budget \$300,000.00

Construction Contract: - Base (Roof System) \$251,161.09

- Alternate #1 (Insulation OVIP 6) \$14,038.75 - Alternate #2 (insulation OVIP 3) \$7,799.61 - Project Total \$272,999.45

- Under approved budget (\$27,000.55)

Strategic Purpose:

This action conforms with the Port's strategic plan of Goal 6. Develop and fund a 20-year asset replacement/major maintenance schedule.

Recommendation:

Port staff recommends the construction contract bid award for Roof Replacements of OVIP#6 (IMIA) and OVIP #3 (Belfair Hose) to Signature Roof Services, LLC, in the amount of \$ 272,999.45, and authorize the CEO to issue notice to proceed.

Motion for Consideration:

Move to approve the construction contract award of the 5695 Imperial Way (OVIP #6) and 5737 Imperial Way (OVIP #3) Roof Replacements to Signature Roof Services, LLC, in the amount of \$272,999.45, and authorize the CEO to execute the contract and issue notice to proceed.
