PORT OF BREMERTON KITSAP COUNTY, WASHINGTON RESOLUTION NO. 2024-01 DATED: January 09, 2023

<u>A RESOLUTION</u> of the Board of Commissioners, Port of Bremerton, authorizing the Port's Chief Executive Officer to sell and convey port district property of Ten Thousand Dollars (\$10,000) or less in value according to the criteria outlined in RCW 53.08.090. This authority shall be in force for the calendar year 2024.

<u>WHEREAS</u>, RCW 53.08.090 provides that the Bremerton Port Commission may authorize the Chief Executive Officer to sell and convey port district property of \$10,000 or less in value, and

<u>WHEREAS</u>, prior to any such sale or conveyance, the Chief Executive Officer shall itemize and list the property to be sold and make written certification to the Port Commission that the listed property is no longer needed for port district purposes, and

<u>WHEREAS</u>, any large block of the property having a value in excess of \$10,000 shall not be broken down into components of \$10,000 or less value and sold in the smaller components unless the small components be sold by public competitive bid, and

<u>WHEREAS</u>, no property which is a part of the comprehensive plan of improvement or modification thereof shall be disposed of until the comprehensive plan has been modified to find the property surplus to port needs. The comprehensive plan shall be modified only after public notice and hearing provided by RCW 53.20.010, and

<u>WHEREAS</u>, this resolution shall not repeal or modify procedures for property sales within industrial development districts as set forth in chapter RCW 53.25, and

NOW, THEREFORE BE IT RESOLVED by the Board of Commissioners, Port of Bremerton, that the Chief Executive Officer is authorized to sell and convey port district property of Ten Thousand Dollars (\$10,000) or less in value according to the terms of this resolution and according to the criteria established in RCW 53.08.090, and

<u>BE IT FURTHER RESOLVED</u>, that this authority shall be in force for the calendar year 2024.

Summary:

This project is the beginning of the sewer line replacement Capital project in the Industrial Park. The Airport Office Building, built in 1974, requires a new sewer line replacement. The frequent clogs and sewer back-ups have cost the Port an estimated nine-thousand in emergency plumbing costs since 2022. Previous findings identified a low point "belly" in the sewer line, causing the flow to become easily clogged. However, recent investigations that included a video camera scoping found more concerning issues, including multiple misaligned and separated joints and several points of failure (cracks, bellies, and bends in the line). The sewer pipe also changes into three types: concrete, commercial green, and general-use white, which is not intended for sewer purposes. These pipe changes are consistent with multiple years of patchwork repairs and quick temporary fixes. Because of these findings, several contractors and Port Maintenance recommend a complete sewer line replacement. The proposed line would start from the foundation of the building and go directly to the newly replaced sewer lift station.
