#### **Information Items**

1. Legislative Update – Dylan Doty, Jensen Walgren Doty Governmental Consulting

Mr. Doty discussed the upcoming short 60-day legislative session which begins on January 8. During session on February 20, the Port will hold its annual Day-on-the-Hill in Olympia which is an opportunity to update legislators on Port projects and get their feedback. He detailed session highlights — democrats control both house and senate; operating and transportation budgets expecting minor tweaks; McCleary education funding is expected to remain a main focus; capital budget still not passed — Port has money in it for Port Orchard Marina breakwater. There was also discussion with the board on current transportation studies for Gorst corridor and Tacoma Narrows Bridge to SR3; Volkswagen settlement funds grant packages; setting goals and prioritizing transportation infrastructure needs; policy bill on port broadband telecom authority; and Hirst water issue.

Mr. Doty reported there is an upcoming meeting with the new Washington Department of Fish & Wildlife Regional Director, Larry Phillips, to familiarize him with the Port and discuss the Misery Point boat launch.

#### **Work Study Session**

1. Marina Breakwater Discussion

Robert Wise, Marsh Andersen LLC, stated that for the last several years, the Port has allowed vessels to moor long-term on the outside of the Bremerton Marina breakwater but a policy decision is needed on whether this practice should be continued. He provided a summary of engineering positions by Art Anderson Associates (AAA) and Willy Ahn, formerly with AAA, an engineer of record on the Bremerton Marina reconstruction project:

#### AAA -

- Outside wall of the breakwater is a post-tensioned structure and not designed to moor vessels;
- No cleats were installed in original design;
- Probability of breakwater damage due to vessel impacts increases.

#### Willy Ahn -

- Wind loads can be sustained:
- No mooring hardware installed;
- Wave wall not designed for use of long-term moorage attachments;

- Short-term use only was intended;
- Significant engineering work would be required to engineer moorage solution.

Mr. Wise also reminded the Board that in 2005, due to concerns of Washington State Ferries, the Port committed to not moor boats on the eastside of the breakwater.

Following detailed discussion, the Board stated that moving forward, the Port will no longer allow permanent moorage on the outside of the breakwater but will do everything possible to assist current users in relocating.

## PORT OF BREMERTON KITSAP COUNTY, WASHINGTON RESOLUTION NO. 2018-01

DATED: January 9, 2018

<u>A RESOLUTION</u> of the Board of Commissioners, Port of Bremerton, authorizing the Port's Chief Executive Officer to sell and convey port district property of Eighteen Thousand Seven Hundred Forty-Four Dollars (\$18,744) or less in value according to the criteria outlined in RCW 53.08.090. This authority shall be in force for the calendar year 2018.

- <u>WHEREAS</u>, RCW 53.08.090 provides that the Bremerton Port Commission may authorize the Chief Executive Officer to sell and convey port district property of \$18,744 or less in value, and
- <u>WHEREAS</u>, prior to any such sale or conveyance, the Chief Executive Officer shall itemize and list the property to be sold and make written certification to the Port Commission that the listed property is no longer needed for port district purposes, and
- <u>WHEREAS</u>, any large block of the property having a value in excess of \$18,744 shall not be broken down into components of \$18,744 or less value and sold in the smaller components unless the small components be sold by public competitive bid, and
- <u>WHEREAS</u>, no property which is a part of the comprehensive plan of improvement or modification thereof shall be disposed of until the comprehensive plan has been modified to find the property surplus to port needs. The comprehensive plan shall be modified only after public notice and hearing provided by RCW 53.20.010, and
- <u>WHEREAS</u>, this resolution shall not repeal or modify procedures for property sales within industrial development districts as set forth in chapter RCW 53.25, and
- <u>WHEREAS</u>, the \$18,744 figure designated in this resolution shall be adjusted annually based upon the governmental price index established by the Washington State Department of Revenue.
- <u>NOW, THEREFORE BE IT RESOLVED</u> by the Board of Commissioners, Port of Bremerton, that the Chief Executive Officer is authorized to sell and convey port district property of Eighteen Thousand Seven Hundred Forty-Four Dollars (\$18,744) or less in value according to the terms of this resolution and according to the criteria established in RCW 53.08.090, and
- **BE IT FURTHER RESOLVED**, that this authority shall be in force for the calendar year 2018.
- <u>ADOPTED</u> by the Board of Commissioners of the Port of Bremerton at the regular public meeting thereof held this 9<sup>th</sup> day of January, 2018 and duly authenticated in open session by the signatures of the Commissioners voting in favor thereof and the Seal of the Commission.

#### **Summary**:

On September 26, 2017 the commission awarded Global Diving & Salvage, Inc. the contract for underwater inspection, assessment and repair of both the Bremerton and Port Orchard marinas. The work completed to date includes completion of the Bremerton Marina breakwater inspection/anode replacement, visual and ultrasonic inspection of pilot piles, Level I & II inspection of north breakwater section (taking on water since 2015), and the re-adjustment of the four marker buoys on Turner Joy. Work completed in the Port Orchard marina includes the breakwater inspection and anode replacement, a Level II inspection of 13 Bridal Chain Connections, and ultrasonic wall testing on pilot piles. The contractor has provided a written report. During the inspection of the Bremerton Marina breakwater, the divers observed heavy loss to previously installed anodes and observed surface rusting and minor deterioration to the cables, stud-linked chain and anchor piles. A recommendation was made to replace/install additional anodes to improve the cathodic protection of the anchoring system.

On December 7th the floating camel on the south wave attenuation wall became detached from the wall and was found floating in the marina. The south attachment structure had become jammed on the pilings (12/6) and subsequently separated from the camel resulting in the sinking of the attachment structure.

This change order will facilitate the attachment of 72 additional anodes on the Bremerton breakwater anchorage system and inspection of the south wave attenuation wall components to document damage/failure and assist in establishing a repair plan. The cost of the change order is not to exceed \$19,110.00.

Fiscal Impact: Funds for this change order are available in the 2017 project budget.

<u>Recommendation</u>: Staff recommends approval of the Change Order No. 1.
