Information Items

1. Freedom Boat Club's Time Share Boating – Shawn Ottenbreit, Owner

Mr. Ottenbreit announced the April 7 grand opening for the Freedom Boat Club's Bremerton location. He provided a PowerPoint presentation describing the Sharing Economy concept and the different types of available boating platforms. He also communicated that Boat Clubs were an early Shared Economy forerunner explaining the benefits of being a member of such a club. He included background on the Freedom Boat Club and its expansion to the west coast. He invited everyone to attend Bremerton's grand opening on April 7, 12-4 pm providing detail on the event.

He responded to questions from the board throughout the presentation and there was discussion on parking during the period when the Washington Avenue property is being developed. The board thanked Mr. Ottenbreit for bringing this opportunity to the community.

2. 2018 Seattle Boat Show Report – Bob Wise, Marsh Andersen, LLC and Kathy Garcia, Marina Operations Manager

Mr. Wise reported on the Port's participation in the Seattle Boat Show which is the largest show on the west coast. He provided a list of other public ports in attendance; highlights from the show; and discussed the financial investment which is a great value and return on investment. He and Ms. Garcia responded to questions and comments by the Board.

To enhance the flow of the meeting, President Stokes requested Action Item #1 be discussed next.

Work Study Session

1. Port Building Options

Arne Bakker, Director of Business Development, provided background on previous discussions about constructing a new building in Olympic View Industrial Park's (OVIP) NE Campus which was approved in the 2018 budget. He presented two building options: Option 1 for a 10,000 sq ft building on NE Campus Lot #8 and Option 2 for a

16,000 sq ft building on NE Campus Lot #2. Following in-depth discussion, direction was given to staff to move forward on Option 2, the 16,000 sq ft building, and if enough money remains in the budget, to then also move forward with Option 1, the 10,000 sq ft building.

2. Request for Qualification (RFQ) Discussion – Marina Options

CEO Jim Rothlin provided a recap on discussions to date about the potential for going out for a Request for Qualifications (RFQ) for management services of the marinas after receiving interest from outside companies to provide that service. Public input has been received and staff is now looking for direction on whether to move forward with an RFQ.

Commissioner Bozeman spoke to his concern that giving up management might cause the Port to lose that public part of the structure we call our marina and put at jeopardy the Port's vision of the public being provided access to what we consider a waterfront park.

Commissioner Strakeljahn agreed those were valid concerns but not putting it out to an RFQ might not be wise; could work through issues contractually.

Commissioner Stokes spoke to not being in a position of supporting giving up the responsibility and of the commissioners having control over the waterfront — cannot support going farther with the RFQ process.

Direction to staff was to keep management of marinas with the Port.

Summary:

To apply for a WSDOT grant, the Airport must submit a signed assurance in the form of a resolution that local matching funds are available and authorized for the proposed project. Staff is applying for state funding for the 2018 design of the Airfield Lighting Project for the airport. In the current budget, \$250,000.00 is budgeted for the project. 90% of the project will be funded by the FAA. The WSDOT grant would represent 5% of the project which equals \$12,500.00. The project involves replacing the airfield lighting and signage which are passed their useful life. The majority of the lighting and signage will be converted to LED. The project will also include upgrading the airport's rotating beacon and electrical vault as well as relocating the windsock and segmented circle.

Fiscal Impact:

A savings of \$12,500.00

Recommendation:

Support application for a WSDOT grant for the 2018 Design of the Airfield Lighting Project.
