### **Information Items**

1. Washington Avenue Property Update – Sound West Group

Wes Larson, Principal, provided history and an overview of Sound West Group including their development strategy and detail on past projects. There was discussion with the Board on rental rates in Bremerton and potential methods for attaining affordable housing.

Mike Brown, Principal, described drawings that will be presented to the design review board for the Marina Square project in downtown Bremerton at Washington Avenue and 2<sup>nd</sup> Street and provided details of the layout which includes a Cambria Hotel and Suites and a residential building. Included will be three garage levels with the lowest level off second street containing Port parking for marina tenants. He discussed several portions of the project including ownership/maintenance of the courtyard; how the project will complement the Harborside steps; capability of including commercial with residential; view from the project area; public access; floorplate drawings for 9 levels; overall parking; and a potential pier/bridge over to the boardwalk. Mr. Brown responded to questions and comments from the Board and CEO. The Board and CEO thanked Sound West for their vision and interest in the community stating the Port relied on picking the right partner and watching this project morph into what is happening is beyond expectation.

2. Bremerton Bridge Blast – Boomtown Productions LLC

Sunny Saunders, Sunny Jack Events, and John Miller, Boomtown Productions, provided background on their companies. Mr. Miller announced this year's Bridge Blast would be held on June 30, 2018. Commissioner Stokes suggested they communicate and coordinate with Port Orchard due to the Fathoms O'Fun parade being held the same day. Ms. Saunders provided a summary of the 2017 event including photos and discussion on funding. She and Mr. Miller gave an overview of the plans for the 2018 Bridge Blast including the VIP event on the USS Turner Joy, an airshow, anticipated logistics with a potential need for marina and airport assistance, and City of Bremerton support. There was discussion about the logistics cost and the need for \$60,000 for the event with sponsorship of \$50,000 needed. Sponsorship levels were provided and the Board suggested any request for support be put in writing for consideration; however, it was noted this type of funding for 2018 had already been obligated.

Attended this meeting in support of the Bridge Blast but took the opportunity to thank
the Port for their partnership in the USS Turner Joy preservation project and to provide
an update on the programs associated with the Turner Joy. Commissioner Bozeman
urged BHSA to build up the board in support of Mr. Hanson so there is a good
succession plan.

On March 27, the marina staff presented the revision of current Marina Rules and Regulations, which was last updated on February 23, 2011. The previous presentation of the revisions will be revisited. The details have since been reviewed and approved by legal counsel.

### **Fiscal Impact**:

### Recommendation:

Approve revisions to the Marina Rules and Regulation to go into effect June 1, 2018. This will allow time to revise other marina documents, including the moorage lease agreement, so that all are consistent with each other.

# Rules and Regulations – Administrative Changes

- Licensor/Licensee vs. Landlord/Tenant
- Recreational Operators Liability Insurance Changes
  - Vessels less than 60' unchanged at \$300,000
  - Vessels greater than 60' increased to \$500,000
- Commercial Vendor Liability Insurance Coverage
  - Minimum coverage increased to \$1M
- Consolidate ancillary deposits with moorage deposit
- Minor tweaks to sub-leasing arrangement licensee shall provide parking and access credentials to anyone who uses their slip
- Copy of Washington vessel registration must be updated annually with the office
- Added copies of the applicable state laws for how abandoned vessels are dealt with



## Rules And Regulations – Policy Changes

- No permanent moorage will be allowed on the outside of the marina break water
- Temporary moorage on the outside of marina break water will be limited to 72 hours. Extended periods must be approved through Port commission
- Discounts for licensee to use guest moorage eliminated on 3 busiest holiday weekends
- Background checks implemented for new live aboard licensee. Background check fees paid by applicant.
- Liveaboard privileges limited to immediate family members
- Airbnb, VRBO and other similar operations will not be allowed

### **Summary**:

Negotiations of the 2018-2021 Union Agreement with the Teamsters Local Union 589 have been completed, with the union members voting to accept the contract on April 12, 2018. The Contract runs from June 1, 2018 through May 31, 2021. Ratification of the Agreement is required by the Port Commission.

### **Fiscal Impact**:

The financial impact to the effective Contract date of June 1, 2018 is based on 3.3% COLA increase. COLA increase is capped at 3.5%.

VRC, LLC lease approximately 1.49 acres in the Olympic View Industrial Park. This amendment has a rental rate adjustment for year 2018 through 2023. ## AMENDMENT TO LEASE No. 6 VRC LLC

IT IS HEREBY AGREED by and between the PORT OF BREMERTON, a municipal corporation organized under the laws of the State of Washington, hereinafter referred to as "Port" and VRC, a Limited Liability Company, hereinafter referred to as "Lessee", to amend that certain lease dated May 9, 1978 (Auditor's file #7806270104); amended January 14, 1991; and further amended November 9, 1999, January 28, 2003, May 13, 2008, and May 8, 2013 and as assigned from James H. Robinson and Audrey M. Robinson, husband and wife; James E. Carlson and Shirley Carlson, husband and wife; Gerard S. Vergeer Jr. and Shirley Vergeer, husband and wife, to read as follows (all other terms remain the same):

### 4. <u>RENT</u>

Lessee shall pay to the Lessor in annual installments, in advance on or a. before the 1st day of May of each year, 2018 through 2023, the sum of FIVE THOUSAND THREE HUNDRED THIRTY FOUR and 21/100 DOLLARS (5,334.21). Said sum is computed at a rate derived from five years (2012 through 2017) of cumulative change to the CPI-U Seattle-Tacoma-Bremerton Index in accordance with provisions in paragraph 4.b of the original lease. The Lessee hereby agrees and accepts that it is leasing approximately 1.49 acres of land. In the event any rental payment is not made within ten (10) days of its due date, Lessee shall also pay the Port a late payment penalty in the amount of \$50.00 for each such delinquent rental payment, together with interest on the delinquent total at the rate of eighteen percent (18%) per annum (minimum \$20.00 per month) until the delinquency is cured. The acceptance of rent by the Port for any period or portions thereof after default by the Lessee shall not constitute a waiver of the default unless the Port so notifies Lessee in writing. The Lessee agrees that the Port shall have a lien against all assets of the Lessee located on the Premises or used in connection with the Lessee's occupation of the Premises for all rents, charges, interest and fees payable under this Lease, and the Lessee further agrees that it shall not remove any of said assets from its locations until all such charges and fees payable under this Lease are paid in full.
