1. Bremerton Aviation Center for Education (BACE) Update – Mike Friend, Experimental Aircraft Association (EAA)

Mr. Friend provided a status report detailing:

- What is new:
 - Electric airplane build progress.
 - Two build team members have started FAA certified Airframe and/or Powerplant (A&P) mechanics school.
 - Several youth members have started flight training.
 - New youth go through BACE's Build & Fly program (constructing remote control airplanes) before graduating to the full-size airplane build program.
- Next steps:
 - Mount systems into the plane.
 - Fundraising to support the second BACE airplane kit.
 - Working toward BACE becoming an energy-independent operation. Currently partnering with the Port on a refresh of the BACE building to include a provision for solar energy.
 - Completion of BACE electric motorglider and flight testing
 - Commissioning of ramp recharging capabilities
